



## Moberly School District meal bus delivery Nov 13 – 24, 2020

Moberly School District will deliver meals using special bus routes for area children ages 1-18 during the November 10 – 24 school building closure.

- Deliveries will start on Friday, November 13th at 3:00 pm.
- Busses will deliver meals each Tuesday and Friday starting at 3:00 pm. The last delivery will be Tuesday, November 24<sup>th</sup>.
- You do not need to sign up or order in advance. The bus will stop at the published bus route stops, someone must be at the bus stop to receive the meals from the driver.
- Tuesday's delivery will include breakfast and lunch for Wednesday – Friday.
- Friday's delivery will include breakfast and lunch for Saturday – Tuesday.
- All Moberly area children ages 1-18 are eligible.

We will still offer drive through meal pick up each Monday at Moberly High School between 10:00 am – 12:00 pm.

- Meals must be pre-ordered weekly.
- You must submit your pre-order for the next week by Friday at 10:00 am.
- To pre-order meals complete the survey form on our website. If you are unable to submit your order online, you may call the school secretary to place your order.
- Meals can be picked up each Monday between the hours of 10:00 am – 12:00 pm at Moberly High School.
  - Drive through line at High School: Enter the main drive and drive toward the kitchen door on the North side of the building, just East of the Weight Room door.
